# **Environmental focus**

We maintain **BS ISO 14001:2015** certification for our Environmental Management System and strive to minimise the environmental impact of our business activities. We set defined environmental targets and work as a team to achieve these and pro-actively manage our performance.

We adopt a 'prevent, reduce, re-use, recycle' approach to our waste, and ensure the correct disposal of all remaining materials.

#### What we are already doing:

Our modern head office is fossil fuel free. We operate with electricity from 100% renewable sources and incorporate energy saving design.

We minimise pollution by ensuring our workplace transport and plant operations are as fuel-efficient as possible through planned preventative maintenance and service. Our fleet includes hybrid and fully electric vehicles and our charging stations are supplied with 100% renewable source electricity.

Our haulier network is managed to optimise least cost routing & minimise empty running.

We are a FORS supporter which encourages good practice in fleet safety, efficiency and environmental impact.

We utilise responsible waste service providers who dispose as follows:

- Paper & card –100% is diverted from landfill and is recycled
- General waste 100% is diverted from landfill and is used to generate electricity
- Glass, tin, plastic recycled where possible
- Hazardous recycled, organic composting or digestion, refuse derived fuel, treated & landfill if no other option
- Hygiene 100% is diverted from landfill and is used to generate electricity

We email customer invoices wherever possible to avoid hard copy in post and we are investing in a document management software and workflow solution to provide electronic POD's and invoices.

We have a companywide sustainable purchasing policy that takes a whole life cost approach whilst also considering environmental, social & ethical impacts. We will:

- Purchase from ethical and sustainable sources locally where possible
- Buy energy efficient products
- Buy environmentally friendly products to minimise use of hazardous chemicals
- Buy recycled products when appropriate
- Ensure packaging and used goods are disposed of in an environmentally friendly way
- Comply with current legislation and anticipate future requirements

We have best practice guidance in place for purchase of energy, IT equipment, IT consumables, office furniture, stationery, paper, cleaning materials, paints, food, transport & recycling.

Our environmental footprint is constantly evolving and we are engaged to adapt our current activities further to meet the requirements of the Greenhouse gas protocol on reducing emissions in line with scopes 1,2 and 3. We have established our carbon footprint and will identify & plan action against our biggest improvement opportunities to support our ambition of becoming a net zero business.
